

AIRCRAFT

(Tariff KPM – 01 A)

effective date 1ST January 2023

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players and similar devices in aircrafts, including digitized music during air journeys, and applies to all aircrafts registered in Kenya.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all aircrafts registered in Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to the total seating capacity of each Carrier (aircraft).

2.2 The rates are exclusive of any applicable taxes.

PUBLIC TRANSPORT TERMINUS

(Tariff KPM – 01 B)

effective date 1ST January 2023

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music, as background performances in all the common areas within air terminus (airports/airstrips), marine terminus and Bus and Railway stations in Kenya. The scope does not include other private businesses domiciled within the controlled areas of the termini – such businesses shall be licensed separately if their sources of performances are different from that of the common areas.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all public transport termini in Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a flat figure rate per each terminus.

2.2 The rates are exclusive of any applicable taxes.

COMMERCIAL MOTOR VEHICLES

(Tariff KPM – 02)

effective date 1ST January 2023

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video players, and similar devices including digitized music, as background performances in all commercial vehicles and vessels that include Trucks, Lorries, Trailers, Pick-ups, Public service vehicles, Tourist service vehicles, Taxi cabs, Train Wagons and coaches, Marine Vessels, Car hire vehicles and all other similar commercial vehicles. The scope does not include private vehicles and vessels.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all public transport commercial vehicles and vessels in Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The LICENCE FEES are calculated by reference to a flat figure rate per each applicable classification based on seating capacity cluster.

2.2 The rates are exclusive of any applicable taxes.

MUSIC IN SCHOOLS, PROFESSIONAL TRAINING PROGRAMS, DANCE SCHOOLS AND DISC JOCKEY ACADEMIES

(Tariff KPM – 03)

effective date 1ST January 2023

1. SCOPE OF TARIFF

This tariff applies to the performances/usages of music and audiovisual works incorporated as background in audio-visual programs used for purposes of education or training, irrespective of whether the programs are presented as part of a course at an institute for formal education or whether they form part of so-called "in-house" training programs and provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music. The scope includes all schools (private and public), universities and other institutions of higher learning. The scope shall also include the normal performances in common areas of the institution – school halls, and other areas, and during extra curriculum musical activities.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all usages listed in the scope above in Kenya, and to performances/usages of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances/usages commence. Any performances/usages not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a flat figure rate per annum per the number of learners in each institution.

2.2 The Rates are exclusive of any applicable taxes.

AMUSEMENT PARKS/ARCADES AND FAIRGROUNDS

(Tariff KPM – 04)

effective date 1ST January 2023

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music, as background performances in all the common areas within the controlled areas of the amusement parks and arcades and Fairgrounds and similar establishments.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all public transport termini in Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff.

KAMP-PRISK-MCSK shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** for the performance of background music in Amusement Arcades/Parks and Fairgrounds are calculated by reference to a flat rate based on each classification per geographical location and regional status.

2.2 The rates are exclusive of any applicable taxes.

CINEMAS

(Tariff KPM – 05)

effective date 1ST January 2022

1. SCOPE OF TARIFF

This tariff applies to the performances of musical works, sound recordings and audiovisual works given during, or in connection with the exhibition of **films** at cinemas or other premises at which the commercial exhibition of films regularly takes place during the year.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies to all **Cinema sites** in Kenya, and only to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

- 2.1** The **LICENCE FEES** are calculated by reference to a flat figure rate per each **Cinema Site**, irrespective of the number of Cinema theatres in the site, geographical location, classification and or seating capacities.
- 2.2** This tariff shall cover the following categories of public performances: -
- i. as an accompaniment to the exhibition of films including filmed advertisements whether the repertoire is performed by means of the soundtrack of a film or otherwise.
 - ii. performances for intermissions, play in, and play out purposes.
 - iii. performances in cinema foyer and all other areas within the said premises under the control of the licensee, but only as a relay of music being performed in one of the auditoria or the music comprised in forthcoming attractions, provided that the foyer or area does not have seating accommodation used for the purposes of a café or otherwise for the consumption of refreshments.
 - iv. performances in the form of not more than three items of variety entertainments introduced before, during or after each exhibition of the complete picture program.

2.3 “Cinema site” means cinema premises with one or more screens owned or operated by the same person(s).

2.4 “Film” means a recording on any medium from which a moving image may by any means be produced.

2.5 The rates are exclusive of any applicable taxes.

PRIVATE MEMBERS' CLUBS

(Tariff KPM – 06)

effective date 1ST January 2023

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music, as background performances in all the common areas within the controlled areas of the Private members' club and similar establishments.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all establishments as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

- 2.1 The **LICENCE FEES** for the performance of background music and audiovisual works in private members' clubs are calculated by reference to a flat rate per annum, and per geographical location and regional/municipality status.
- 2.2 The rates are exclusive of any applicable taxes.

DISCOTHEQUES, NIGHT CLUBS AND DANCE HALLS

(Tariff KPM – 07)

effective date 1ST January 2023

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music, as background performances at premises where dancing takes place to recorded music, irrespective of whether such performances are given by the proprietors of the premises or by a third party such as the owner of a licensed mobile discotheque service. It does not apply to premises where the main consideration of admission is the purchase of a meal (A fee is charged for admission).

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all establishments as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

- 2.3 The **LICENCE FEES** for the performance of background recorded music and audiovisual works for dancing are calculated by reference to a flat rate per annum, and per geographical location and regional/municipality status.
- 2.4 The rates are exclusive of any applicable taxes.

EXHIBITION OF VIDEO SHOWS

(Tariff KPM – 08)

1. SCOPE OF TARIFF

This tariff applies to the performances of musical works, sound recordings, and audiovisual works during, or in connection with the exhibition of recorded videos in halls or other premises other than cinemas, in which the commercial exhibition regularly takes place during the year.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all establishments as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a flat figure rate per each premise, irrespective of the number of exhibition screens in the premise, geographical location, classification and or seating capacities.

2.2 The rates are exclusive of any applicable taxes.

HOTELS AND OTHER ACCOMODATION ESTABLISHMENTS

(Tariff KPM – 09A)

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music, as background performances in all the common controlled areas of Hotels, Motels, Lodgings, Game Lodgings, Serviced Apartments and Similar accommodation establishments.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all establishments as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a Percentage of the respective Single Business Permit and Liquor Licenses.

2.2 The rates are exclusive of any applicable taxes.

RESTAURANTS, BARS, CAFES AND SIMILAR ESTABLISHMENTS

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music, as background performances in all the common controlled areas of Restaurants, Cafes, Bars, Casinos and other similar Food, gaming and Liquor Retailing establishments.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all establishments as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a Percentage of the respective Single Business Permit and Liquor Licenses.

2.2 The rates are exclusive of any applicable taxes

MEDICAL FACILITIES

(Tariff KPM – 10)

1. SCOPE OF TARIFF

This tariff applies to the performances of music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music, as background performances in all the common controlled areas of medical facilities that include Hospitals and Clinics (both Public and Private), including Doctors’ workplaces and centers.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all establishments as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a Flat rate per annum and the classification based on the official level-grading.

2.2 The rates are exclusive of any applicable taxes

MOBILE DISC JOCKEYS

This **TARIFF** applies only to usages as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

- a. The **LICENCE FEES** are calculated by reference to a Flat rate per annum with an option for a per event license.

CONCERTS AND OTHER LIVE MUSIC EVENTS

1. SCOPE OF TARIFF

This tariff applies to the performances of both live and recorded music and audiovisual works provided by means of radio receiving sets, disc players, tape machines, video cassette players, television and similar devices including digitized music on one part, and live performances on the other, during concerts and events where no direct or indirect charge is made (Non – paying concerts) and where a direct or indirect charge is made (Paying concerts).

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to all establishments as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

- 2.1 The **LICENCE FEES** are calculated by reference to Gross Income from admission charges on the provision of live/recorded music subject to a minimum fee per event for paying concerts and Gross Expenditure on the provision of live/recorded music subject to a minimum fee per event for Non-paying concerts.
- 2.2 For the purposes of this tariff, the phrase "**Gross Income or Gross Expenditure on the provision of live/Recorded music**" means the Total income received or Total Expenditure spent in Paying and Nonpaying events respectively.
- 2.3 The rates are exclusive of any applicable taxes

ROADSHOWS

This tariff applies to performances of recorded music and audiovisual works by means of devices such as radio, Television sets, disc players or tape machines and live band performances including digitized music by mobile or travelling disc jockeys aboard mobile trucks and other vehicles. A license under this tariff is issued to companies and or organizations to whom products and or promotional themes belong, not the owners of the trucks and other vehicles in use.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to usages as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a Flat rate per annum with an option for a per event license and based on the type of vehicle in use and classification of the organization promoting its theme or product – MSMEs, SMEs or large corporates.

2.2 The rates are exclusive of any applicable taxes

This **TARIFF** applies only to usages as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a Flat rate per annum with an option for a per event license and based on classification of the organization promoting its theme or product – SMEs or large corporates.

2. GENERAL CONDITIONS AND DEFINITIONS

This **TARIFF** applies only to usages as outlined in the scope above within the Republic of Kenya, and to performances of musical works, sound recordings and audiovisual works covered by a license from **KAMP-PRISK-MCSK**, obtained before the performances commence. Any performances not so covered will be assessed at **double** this tariff. **KAMP-PRISK-MCSK** shall be bound to offer a joint license under this tariff in respect of any performances for which application was made in advance.

2.1 The **LICENCE FEES** are calculated by reference to a Flat rate per annum and on geographical location based on municipality rating.

2.2 **KAMP-PRISK-MCSK** jointly reserve the right to make such variations in this tariff as they consider appropriate for performances which, in their opinion, do not fall within the scope of this tariff.
